## III. Resolution on Purchasing Land for Construction of Zhengzhou Strategic R&D Service Base

The Company plans to purchase a land at Plot 3 as in Zheng Zheng Dong Chu [2014], with a land area of 56.141 Mu, equivalent to 37,427.47 square meters. The total purchasing price will not exceed the amount approved by the Board.

# IV. Resolution on Adjusting Compositions of Some Special Committees of the 6<sup>th</sup> Session BOD
